RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH INSTITUTE OF BUSINESS, SCIENCE, AND MEDICAL ARTS (IBSMA) FOR THE PROVISION OF EDUCATIONAL OPPORTUNITIES THROUGH SCHOLARSHIP TO DESERVING RESIDENTS OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, pursuant to Sec. 22(c) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, the Institute of Business, Science, and Medical Arts (IBSMA) is a private higher education institution with an office address in Barangay Marfrancisco, Pinamalayan, Or. Mindoro has expressed its willingness to be in partnership with the Municipal Government of Pinamalayan to provide scholarship opportunities to deserving residents of this municipality;

WHEREAS, the objective of this Memorandum of Agreement (MOA) is to establish a formal partnership between the Municipal Government of Pinamalayan and IBSMA to promote and enhance educational opportunities for Pinamalayan residents through scholarship provision;

WHEREAS, a scholarship program provides financial support awarded to a student based on academic achievement or other criteria, including financial need to facilitate their education;

WHEREAS, IBSMA has committed twenty-five (25) scholarship slots, valid for the duration of four (4) years or the duration of the course whichever is shorter, allocated to various programs offered by the institution;

WHEREAS, the Municipal Government of Pinamalayan and IBSMA agree to the terms and conditions outlined in the Memorandum of Agreement, which shall form an integral part of this resolution.
