MUNICIPAL ORDINANCE NO. 09 -2021

AN ORDINANCE AMENDING SOME ITEMS IN SECTION 3 OF ORDINANCE NO. 03-2021 ENTITLED "CONFIRMING, APPROVING AND RATIFYING THE LOAN AGREEMENT OF THE MUNICIPALITY OF PINAMALAYAN, PROVINCE OF ORIENTAL MINDORO WITH THE LAND BANK OF THE PHILIPPINES (LBP) IN THE AMOUNT OF TWO HUNDRED FIFTY MILLION (PHP 250,000,000.00) PESOS TO FINANCE THE CONSTRUCTION OF THE LGU'S ROAD DEVELOPMENT PROGRAM UNDER THE RISE-UP LGU LENDING PROGRAM."

WHEREAS, Municipal Ordinance No. 03-2021 of this municipality was duly approved by the Sangguniang Panlalawigan on March 10, 2021 as per Resolution No. 5432-2021;

WHEREAS, during the Pre-Procurement Conference, some typographical errors were noted in the description and title of various projects which were reflected in the aforementioned Municipal Ordinance;

WHEREAS, the Sangguniang Bayan recognizes the necessity of its amendments for the realization and implementation of the specified projects and for continuous delivery of services to the public.

BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro.

- THAT -

SECTION 1. This Ordinance shall be known as Ordinance amending some items in Section 3 of Ordinance No. 03-2021 entitled "Confirming, approving and ratifying the loan agreement of the Municipality of Pinamalayan, Province of Oriental Mindoro with the Land Bank of the Philippines (LBP) in the amount of Two Hundred Fifty Million (Php 250,000,000.00) pesos to finance the construction of the LGU's road development program under the Rise-Up LGU Lending Program."

SECTION 2. There were some revisions/insertions/adjustments/ made on the itemized projects indicated in the following items in Section 3 of Municipal Ordinance No. 03-2021, hereby amended, and shall be read as:

SECTION 4. SEPARABILITY CLAUSE. If, for any reason, a portion or portions of this ordinance is declared unconstitutional or invalid, the same shall not affect the validity of the other provisions not affected thereby.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval, publication and compliance with all procedures required under Republic Act 7160 of an ordinance for its validity, including the affixation of signatures of the Sangguniang Bayan members, in concurrence thereto, composing of atleast a majority thereof, out of the total ten (10) members, on all pages of this Ordinance.






