MUNICIPAL ORDINANCE NO. 10-2021

AN ORDINANCE ADOPTING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) 2019-2023 OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO SUBJECT TO FULL COMPLIANCE WITH ALL APPLICABLE LAWS, RULES AND REGULATIONS

WHEREAS, pursuant to Department Order No. 2017-011 issued by the Department of transportation (DOTr) and Joint Memorandum Circular (JMC) No. 001, dated 19 June 2017 issued by the DOTr and the DILG, local government units (LGUs) are prompted to promote reliable, safe, accessible, environmentally sound, and comfortable Public Utility Vehicles (PUVs) for the efficient performance of daily socio-economic activities;

WHEREAS, Section 4 (d) (iii) JMC No. 001, Series of 2017, provides that upon the issuance of a Notice of Compliance (NOC), an Ordinance shall be passed adopting the LPTRP and the same shall be endorsed to the Land Transportation and Franchising Regulatory Board (LTFRB) for the conduct of a transparent operator election and issuance of franchises;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991 states that the local government units, shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order and preserve the comfort and convenience of the inhabitants;

WHEREAS, the LPTRP 2019-2023 of Pinamalayan has been found compliant by the Land Transportation for Franchising and Regulatory Board, Regional Office No. IV with Notice of Compliance granted by the said office on 17 June 2021;

WHEREAS, the Local Chief Executive indorsed this planning documentation to the Sangguniang Bayan for its adoption through enactment of an Ordinance;

WHEREAS, it is deemed necessary to adopt the LPTRP 2019-2023 which is consistent with the municipality's goal in ensuring safe mobility of people, goods and services that is facilitated through the provision of an effective, efficient, and climate resilient transport network;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan that:

SECTION 1. TITLE – This Ordinance shall be known as the AN ORDINANCE ADOPTING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) 2020-2023 OF PINAMALAYAN, ORIENTAL MINDORO.

SECTION 2. OBJECTIVES - The adoption of the LPTRP 2019-2023 is intended: (a) to strengthen the implementation of traffic rules and regulations; (b) To improve and construct route network facilities; (c) To formulate a Tricycle modernization program; and (d) To improve the safety of tricycle transportation.

SECTION 3. DEFINITION OF TERMS – For the purpose of this Ordinance, the following terms shall mean:

3.1. LPTRP – The Local Public Transport Route Plan formulated by the Municipal Government of Pinamalayan detailing the route network, mode, and required number of units per mode for delivering public land transport services, approved by the Department of Transportation and Land Transportation and Franchising Regulatory Board, which serves as a comprehensive local transport plan.

3.2. **NOC** – The Notice of Compliance dated June 17, 2021 issued by the LTFRB Regional Office No. 4 approving the LTFRB and the prescribed rationalized routes, authorized mode, and number of authorized units.

SECTION 4. ADOPTION OF LPTRP — The LPTRP as approved under the NOC is hereby adopted, subject to full compliance with all applicable laws, rules and regulations. A copy of the LPTRP shall form part of this Ordinance.

SECTION 5. COVERAGE – The LPTRP shall apply to all rationalized routes approved under the NOC with the specified authorized mode and numbers of authorized units as prescribed in the NOC issued on 17 June 2021, to wit:

SECTION 6. COMPLIANCE WITH LOCAL REGULATIONS – All operators granted a franchise under the LPTRP shall comply with all transportation and traffic regulations prescribed by LPTRB and other related national laws.

SECTION 7. SANCTIONS FOR INIMICAL ACTS – The LTFRB shall impose appropriate sanctions or penalties, including the suspension or cancellation of the franchise, against any operator who will violate the LPTRP, or commit acts inimical to the interest of the travelling public in Oriental Mindoro, in accordance with applicable rules and regulations.

SECTION 8. REPEALING CLAUSE – All local ordinances, executive orders, rules and regulations inconsistent with DILG-DOTr JMC No. 001, series of 2017 and this ordinance are hereby deemed modified or amended.

SECTION 9. SEPARABILITY CLAUSE – If any provision of this ordinance is declared invalid, the remainder or any provision hereof not affected hereby shall remain in force and effect.

SECTION 10. EFFECTIVITY – This Ordinance shall immediately take effect upon approval, subject to full compliance with the posting or publication requirements under RA No. 7160 and its IRR.
