ORDINANCE NO. 03-2020

AN ORDINANCE ADOPTING PROVINCIAL ORDINANCE NO. 112-2020 ENTITLED "INSTITUTIONALIZING THE COMPULSORY USE OF FACE MASKS, CLOTH MASKS, IN THE IMPLEMENTATION OF ENHANCED COMMUNITY QUARANTINE IN ORIENTAL MINDORO DURING THE PERIOD OF NATIONAL HEALTH EMERGENCY AND STATE OF CALAMITY, UNLESS FURTHER EXTENDED, MODIFIED OR WITHDRAWN", AND MODIFYING SECTION 3 THEREOF.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro.

For the immediate implementation of Provincial Ordinance No. 112-2020, entitled "INSTITUTIONALIZING THE COMPULSORY USE OF FACE MASKS, CLOTH MASKS, IN THE IMPLEMENTATION OF ENHANCED COMMUNITY QUARANTINE IN ORIENTAL MINDORO DURING THE PERIOD OF NATIONAL HEALTH EMERGENCY AND STATE OF CALAMITY, UNLESS FURTHER EXTENDED, MODIFIED OR WITHDRAWN", all provisions shall hereto be adopted by the Municipality of Pinamalayan except to its penalties prescribed in Section 3 which shall be modified into sanction which applicable for the municipality of Pinamalayan.

Section I. **TITLE:** This ordinance shall be known as "Compulsory Use of Face Masks, Cloth Masks in the Implementation of the Enhanced Community Quarantine.

Section II. **DECLARATION OF THE POLICY:** It is the policy of the Local Government of Pinamalayan to adopt and implement measures designed to promote and protect the health and welfare of its inhabitants. As vested in the Local Government Code of 1991, within their respective jurisdictions, all local government units shall ensure and promote health and safety and preserve the comfort and convenience of their inhabitants.

Section III. **MODIFICATION:** Section 3 states that "Any persons found violating this Ordinance shall be subject to the following penalties:

- 3.1 First Offense, Fine of P1,000.00;
- 3.2 Second Offense, Fine of P3,000.00;
- 3.3 Third Offense, fine of P5,000.00; and
- 3.4 Fourth and subsequent Offenses, Imprisonment of One (1) month for each separate violation."

is hereby modified, to read as follows:

First Offense	-	Fine of P500.00
Second Offense	-	Fine of P1,000.00
Third Offense	-	Fine of P2,500.00
Fourth and Subsequent Offenses	-	Imprisonment of One (1) month for each separate violation

Section V. **ADMINISTRATIVE PROVISION:**

1. It shall be mandatory for all residents of Pinamalayan, Oriental Mindoro to wear face masks, cloth masks or any form of face cover or shield at all times when going out of his residence of to public places during the period of national public health emergency, unless further extended, modified or withdrawn.
2. All Barangay Chairmen and Councils in the Municipality of Pinamalayan shall immediately create a Barangay Task force to implement and enforce this Ordinance and post copies thereof in three (3) conspicuous places in the barangay.





Should the declaration of national public health emergency be lifted, the regulations imposed in this Ordinance shall be suspended accordingly.


