ORDINANCE NO. 04-2020

AN ORDINANCE ADOPTING PROVINCIAL ORDINANCE NO. 111-2020 ENTITLED, "AN ORDINANCE TEMPORARILY BANNING THE SALE AND DISTRIBUTION, AND REGULATING THE CONSUMPTION OF LIQUOR IN THE PROVINCE OF ORIENTAL MINDORO WITHIN THE DURATION OF ENHANCED COMMUNITY QUARANTINE AND IMPOSING PENALTIES IN CASE OF VIOLATION THEREOF" AND MODIFYING 5.1, SECTION 5 THEREOF.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro that:

For the immediate implementation of Provincial Ordinance No. 111-2020, entitled, "AN ORDINANCE TEMPORARILY BANNING THE SALE AND DISTRIBUTION, AND REGULATING THE CONSUMPTION OF LIQUOR IN THE PROVINCE OF ORIENTAL MINDORO WITHIN THE DURATION OF ENHANCED COMMUNITY QUARANTINE AND IMPOSING PENALTIES IN CASE OF VIOLATION THEREOF", all provisions shall hereto be adopted by the Municipality of Pinamalayan except to its penalty prescribed in 5.1, Section 5 which shall be modified into sanction which applicable for the municipality of Pinamalayan.


Section I. TITLE - This Ordinance shall be known as the "Temporarily banning the sale and distribution, and regulating the consumption of liquor within the duration of ECQ in the Municipality of Pinamalayan, Oriental Mindoro"

Section II. MODIFICATION: 5.1, Section 5 – Penalties, states that "Any person of legal age or business entity found to have violated this ordinance shall be penalized with a fine of Five Thousand Pesos (Php5,000.00), or imprisonment of three (3) months, or both at the discretion of the court" is hereby modified to read as follows:


" 5.1, Section 5 – Penalties: Any person of legal age or business entity found to have violated this ordinance shall be penalized with a fine of Two Thousand Five Hundred Pesos (Php2,500.00), or imprisonment of three (3) months, or both at the discretion of the court"

Section III. Effectivity: This Ordinance shall take effect immediately after compliance with requirements of posting and/or publication under Section 59 © and 511 (a) of the Local Government Code of 1991, and shall in full force and effect during the Enhanced Community Quarantine period imposed by the National Government.
