MUNICIPAL ORDINANCE NO. 08-2020

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 06-2020 ENTITLED: "AN ORDINANCE IMPOSING CURFEW HOURS IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO FROM EIGHT O'CLOCK IN THE EVENING (8:00 PM) TO FIVE O'CLOCK IN THE MORNING (5:00 AM) DURING THE IMPOSITION OF COMMUNITY QUARANTINE DUE TO COVID-19 AND PUBLIC HEALTH EMERGENCY".

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support the promotion of health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants as provided in Section 16 of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipal Government of Pinamalayan finds substantial reasons for the amendment with consistent to the guidelines in the implementation of Modified General Community Quarantine (MGCQ) in the entire Province of Oriental Mindoro amid Covid-19 pandemic;

WHEREAS, as per Executive Order No. 36, series of 2020 of the Provincial Government of Oriental Mindoro, curfew hours shall be implemented in accordance with the respective City/Municipal/Barangay Ordinances;

WHEREAS, the Municipal Government of Pinamalayan is committed in protecting its constituents in most cases, the protection amid public health emergency and global pandemic situation in the municipality;

NOW THEREFORE, BE IT ENACTED BY THE SANGGUNIANG BAYAN OF PINAMALAYAN, ORIENTAL MINDORO, in session assembled, that:

Section 1. Amendments on the Imposition of Curfew Hours; Covered Persons: Section 1 of Municipal Ordinance No. 06-2020 which states that:

"Imposition of Curfew Hours; Covered Persons: There is hereby imposed curfew hours for all persons in the Municipality of Pinamalayan, Oriental Mindoro between Eight O'clock in the evening (8:00 PM) to Five O'clock in the morning (5:00 AM) during the duration of the community quarantine due to Covid-19 and public health emergency imposed by the National Government.

During curfew hours, no person shall be allowed in the streets, commercial establishments, recreation centers, and any public places or other areas outside the immediate vicinity of their residence" is hereby amended to read as follows:

"Imposition of Curfew Hours; Covered Persons: There is hereby imposed the following curfew hours with specified covered persons in the Municipality of Pinamalayan, Oriental Mindoro during the duration of the modified community quarantine due to Covid-19 and public health emergency imposed by the National Government:

1.1. The period and time from Ten O'clock in the evening (10:00 PM) to Four O'clock in the morning (4:00 AM) is hereby declared as Curfew Hours for 19 years old and above.

1.2. The period and time from Eight O'clock in the evening (8:00 PM) to Five O'clock in the morning (5:00 AM) is hereby declared as Curfew Hours for 18 years old and below.


During curfew hours, no person shall be allowed in the streets, commercial establishments, recreation centers, and any public places or other areas outside the immediate vicinity of their residence


Section 2. Separability Clause: If any provision of this Ordinance is declared unconstitutional or inoperative, the other provisions not so declared shall remain in force and effect.


Section 3. Repealing Clause: All Ordinances, rules and regulations, or part thereof, whose provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 4. Effectivity Clause: This Ordinance shall take effect immediately and shall remain in full force and effect during the Community Quarantine and State of Public Health Emergency period imposed by the National Government.
