ORDINANCE NO. 09-2020

ORDINANCE AMENDING SOME PROVISIONS OF THE EXISTING MUNICIPAL ORDINANCE ON THE ENHANCED PINAMALAYAN SCHOLARSHIP PROGRAM AND PROVIDING FUNDS THEREOF, OF THE MUNICIPAL GOVERNMENT OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, in year 2008, the Municipal Council enacted Municipal Ordinance No. 05-2008 establishing the “*Enhance Pinamalayan Scholarship Program and providing funds thereof*”;

WHEREAS, that in year 2009, Section VI, VII and IX of Ordinance No. 05-2008 was later amended under Ordinance No. 12-2009 and Ordinance No. 03-2018;

WHEREAS, with the end, in view of fully realizing the good intentions for which the scholarship program was established, it has been deemed necessary the Municipal Ordinance No. 05-2008, 12-2009 and 03-2018 be revised, respectively;

WHEREAS, the proposed amendment of the existing Municipal Ordinance No. 05-2008 as amended of Municipal Ordinance No. 12-2009 and Ordinance No. 03-2018 shall pave way to a more responsive scholarship program of this municipality;

WHEREAS, the Municipal Scholarship Committee (MSC) of the Municipal Government by virtue of Executive Order No. 51-2016 initiated the amendments through Resolution No. 01, s. 2020 of the MSC;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan that:

Section I. TITLE - This Ordinance shall be known as “**An Ordinance amending the Enhanced Pinamalayan Scholarship Program and providing funds thereof**”

Section II. Section II of Ordinance No. 03-2018 states that “*The Enhanced Pinamalayan Scholarship Program shall provide for the selection of thirty (30) scholar grantees, intended for those intellectually capable high school graduates who cannot afford college education or technical and vocational courses and who are residents of Pinamalayan and allotted slots for qualified applicants from the minority group, residing in Pinamalayan to be selected yearly, to take effect upon approval of this ordinance and shall continue thereafter*” is hereby amendment to read as follows:

“The Enhanced Pinamalayan Scholarship Program shall provide for the selection of thirty scholar grantees, intended for those intellectually capable high school graduates who cannot afford college education or technical and vocational courses and who are residents of Pinamalayan and allotted scholar grantees intended for qualified applicants from the minority group, residing in Pinamalayan to be selected yearly. However, in case the grantee fails to comply with the rules and regulations of the Enhanced Pinamalayan Scholarship Program which subsequently shall cause the termination of the scholarship, the vacated slots will be added to the new batch of scholars”

Section III. Grant of Honorarium for Municipal Scholarship Committee - All members of the Municipal Scholarship Committee (MSC) shall be entitled to receive a reasonable honorarium amounting to One Thousand (Php1,000.00) pesos only for every activity.







Section VI. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately upon its approval.
