ORDINANCE NO. 04-2019

AN ORDINANCE CONFIRMING RESOLUTION NO. 18-2019/ORDINANCE NO. 02-2019 IN NAMING SEVEN (7) SITIO OF BARANGAY BANILAD, PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate or incidental for its efficient and effective government and those which are essential to the promotion of the general welfare as provided in RA 7160, otherwise known as Local Government Code of 1991;

WHEREAS, Barangay Council of Banilad named the seven Sitio of their barangay under Resolution No. 18-2019/Ordinance No. 02-2019;

WHEREAS, the given names of sitio are already recognized and used for a decade which has to be legalized through a confirmation of the Sangguniang Bayan;

WHEREAS, this confirmation is deemed necessary in order to facilitate the delivery of postal matter and basic services and to serve as direct guide for people accustomed in using the names of sitio in the said barangay;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan that:

Section I. TITLE - This Ordinance shall be known as An Ordinance confirming the names of Seven (7) Sitio of Barangay Banilad.

Section II. ADMINISTRATIVE PROVISION – The seven (7) Sitio of Barangay Banilad, Pinamalayan, Oriental Mindoro is hereby named as enumerated herein.

- 1. Sitio Simborio
- 2. Sitio Lig-Ong
- 3. Sitio Comba
- 4. Sitio Proper (Palong)
- 5. Sitio Complex
- 6. Sitio Mahabang Buhangin
- 7. Sitio Bil-isan

Section III. REPEALING CLAUSE - All other ordinances, issuances or parts thereof, in conflict or inconsistent with any provisions of this Ordinance, are hereby repealed, amended or modified accordingly.

Section IV. SEPARABILITY CLAUSE – If any provisions of this ordinance found or declared unconstitutional or unlawful, other section, part or provision not affected by the declaration of invalidity thereby shall remain enforceable and effective.

Section V. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon its approval.
