ORDINANCE NO. 06-2019

AN ORDINANCE AMENDING ITEM NO. 4 OF SECTION 3E.03 UNDER ARTICLE E OF THE MUNICIPAL ORDINANCE NO. 03-2013, THE NEW REVENUE CODE OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate or incidental for its efficient and effective government and those which are essential to the promotion of the general welfare as provided in RA 7160, otherwise known as Local Government Code of 1991;

WHEREAS, the Officers of the Pinamalayan Bahaghari Farmers Federation, Inc. have requested the Municipal Government for the amendments of Section 3E.03 under Article E of the New Revenue Code of Pinamalayan on the Rentals of Municipal Heavy Equipment and Machineries specifically in item No. 4., Tractor (per hour) with rental fee of Php2,000.00 with additional provision therein;

WHEREAS, citing that the tractor rental is excessive considering the term rental is per hour which most of the marginal farmers are not capable to afford the said rental fees due to their unstable economic conditions which apprehended to possibly cause a much lower profit from their farm products;

WHEREAS, finding their reasons as meritorious, the amendment of tractor rental is for the mutual benefits of both the farmers and the LGU;

NOW THEREFORE: BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan in session assembled that:

Section 1. TITLE – This Ordinance shall be known as "An Ordinance amending item No. 4 of Section 3E.03 under Article E of the Municipal Ordinance No. 03-2013, the New Revenue Code Pinamalayan, Oriental Mindoro.

Section 2. DECLARATION OF POLICY - The Sangguniang Bayan of Pinamalayan, Oriental Mindoro presumes that it is appropriate to amend provision being imposed in item No. 4 of Section 3.E.03 under Article E of the Municipal Ordinance No. 03-2013, the New Revenue Code of Pinamalayan in order to conform with the provisions of RA 7160 otherwise known as the Local Government Code of 1991.

Section 3. AMENDMENTS - item No. 4 of Section 3E.03 under Article E of the New Revenue Code, on the Rentals of Municipal Heavy Equipment and Machineries shall be amended.

A. Rental:

4. Tractor (per hour)

Php 2,000.00

The above stated provision is hereby amended and shall be read as follows:

4. Tractor (per hectare)

Php 1,500.00

B. Additional Provision: The crude oil/gasoline of tractor shall be shouldered by the borrower in full tank upon return.

Section 4. REPEALING CLAUSE - All municipal ordinances or parts thereof inconsistent herewith are hereby repealed or modified accordingly.
