





ORDINANCE NO 02-2015

AN ORDINANCE AMENDING SOME SECTIONS/ARTICLES AND ITEMS AND AN ADDENDUM IN ARTICLE C (b), 8. (b) AND CHAPTER V, ARTICLE A. SECTION 5A.03 A. OF THE MUNICIPAL ORDINANCE NO. 03-2013, THE NEW REVENUE CODE OF PINAMALAYAN, ORIENTAL MINDORO.

Section 1 – This Ordinance shall be known as Ordinance amending some sections and items and an addendum in Article C (b), 8. (b) and Chapter V, Article A. Section 5A.03 A. of the Municipal Ordinance No. 03-2013, the New Revenue Code of Pinamalayan, Oriental Mindoro.

Section 2 – The following sections/articles and items OF THE New Revenue Code are hereby amended and shall be read as:

- 2.1. Chapter II, Article A. Sec. 2A, 02, Imposition of Tax. the phrase “a graduated business, within the municipality” between the words municipality and a graduated business tax, shall be deleted.

“Section 2A.02 Imposition of Tax. There is hereby imposed on the following persons who establish, operate, conduct or maintain their respective business, within the municipality, a graduated business tax in the amounts here after prescribed:

- 2.2. Chapter II, Article A. Section 2A.02. d) On retails. In the first paragraph, the item after 2.31% and 1.155, “percent (1%)’ shall be deleted.

“The rate of 2.31% per annum shall be imposed on sale not exceeding Four Hundred Thousand Pesos (Php400,000.00) while the rate of 1.155% per annum shall be imposed on sales in excess of the first Four Hundred Thousand Pesos (Php400,000.00)”

- 2.3. Chapter II, Article A. Section 2A. 02. F), 9. The word “construction” shall be change into “fabrication”.

9. fabrication of motor vehicles, animal drawn vehicles, bicycles and/or tricycles

- 2.4. Chapter II, Article B. (b). Fixed Business Taxes, on the first column, second line, insert the word “air” before the word “conditioning”.

“Buses without air conditioning”

- 2.5 Chapter III, Article E. Section 3E.06. Penalty. The amount of Php5,000.00 shall be reduced to Php2,500.00 for the fine.

“Section 3E. 06. Penalty. Any violation of the provision of this Article shall be punished by a fine of not less than One Thousand Pesos (Php1,000.00) but not more than Two Thousand Five Hundred Pesos (Php2,500.00) or imprisonment of not less than one (1) month but not more than six (6) months, or both such fine and imprisonment, at the discretion of the Court.”

2.6. Chapter III, Article L. Section 3L.04. Applicability Clause. Shall be changed from "PD1185" to "RA 9514".

"Section 3L. 04. Applicability Clause. All other matters relating to fire inspection and issuance of permit therefore shall be governed by pertinent provisions of RA 9514 (Fire Code of the Philippines) and other existing laws, rules and regulations."

2.7. Chapter III, Article Q. Section 3Q. 03, 2. Administrative Provisions, shall be changed from "PD1185" to "RA 9514".

"2. The Chief of the Fire Station, BFP shall promulgate the necessary rules and regulations for the proper consideration of the provisions of RA 9514 (Fire Code of the Philippines) and its implementing rules and regulations."

Section 3 – ARTICLE C LOCAL CIVIL REGISTRY FEES under (b), 8. (b). And (b) 9.

3.1. (b) 8. (b) - An Addendum of another item with charges and fees and shall now be read as::

3. Certification upon approval of the petitioner under RA 9048 and RA 10172 Php500.00

3.2. (b) 9. *Other legal documentation for record purposes*, the stipulated fees therein shall be deleted.

Section 4 – CHAPTER V MUNICIPAL CHARGES AND OTHER FEES, ARTICLE A, Section 5A.03 A. RENTAL FEE ON MARKET PREMISES WITH STALL.


4.1. An addendum of another column for "CLASS B Stalls" with its charges and fees to First, Second & Third Year.

4.2. The specific years stated therein shall be deleted and shall now be read as:

1. CLASS "A" stalls	2. CLASS "B" stalls
First Year <i>Php1.50/sq.meter</i>	First Year <i>Php1.25/sq.meter</i>
Second Year <i>1.75/sq.meter</i>	Second Year <i>1.50/sq.meter</i>
Third Year <i>2.00/sq.meter</i>	Third Year <i>1.75/sq.meter</i>

Section 5 - This Ordinance shall take effect upon approval.
