RESOLUTION NO. 059-2009

RESOLUTION ENACTING AN ORDINANCE REQUIRING FOR THE SUBMISSION OF PHILHEALTH PREMIUM REMITTANCE CERTIFICATE FOR THE ISSUANCE OF PHILHEALTH CLERANCE IN SECURING BUSINESS PERMITS AMONG PRIVATE ESTABLISHMENTS.

WHEREAS, Section 11, Article XII of the 1987 Philippine Constitution declares that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavour to make essential goods, health and other services available to all the people at affordable cost, priority for the needs of the underprivileged, sickly, elderly, disabled, women and children shall be recognized. Likewise, it shall be the policy of the State to provide free medical care to paupers (indigents);

WHEREAS, pursuant to the Administrative Order No. 277 dated June 25, 1996 issued by the Office of the President, the National Government and the Local Government Unit are directed to ensure speedy implementation of the National Health Insurance Program (NHIP);

WHEREAS, R.A. No. 7160, otherwise known as the Local Government Code of 1991, grants Local Government Units (LGU's) genuine autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners of the national goals;

WHEREAS, Section 16 of the Local Government Code provides that every Local Government Unit shall exercise the powers expressly granted those necessary implied therefrom as well as powers necessary, appropriate as incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare within their respective territorial jurisdiction;

WHEREAS, R.A. 7875, otherwise known as NATIONAL HEALTH INSURANCE ACT of 1995 provides for the creation of NATIONAL HEALTH INSURANCE PROGRAM which shall provide health insurance coverage and ensure affordable, acceptable, available and accessible health care services for all citizens of the Philippines;

WHEREAS, Section 6 of the National Health Insurance Act of 1995, provides for the coverage of all citizens of the Philippines in the National Health Insurance Program. The Local Government Units shall ensure and support any other things the preservation and enrichment of culture, promote health and safety, enhance the right of the people to balance ecology, encourage and support the development of appropriate and self-reliant, scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 17 of the Local Government Code states that Local Government Units shall exercise the powers and discharging the duties and functions currently vested upon them. They shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, Section 4 of Revised Implementing Rules and Regulations of the National Health Insurance Act of 1995, provides for the mandatory coverage of the employed in the government and private sectors. The enrollment of the indigent households and individually-paying groups which compromise the majority of Filipinos not covered by Health Insurance shall be ensured;

ORDINANCE NO. 05-2009


AN ORDINANCE REQUIRING THE SUBMISSION OF PHILHEALTH PREMIUM REMITTANCE CERTIFICATE FOR THE ISSUANCE OF PHILHEALTH CLEARANCE IN SECURING BUSINESS PERMITS AMONG PRIVATE ESTABLISHMENTS IN THE MUNICIPALITY OF **PINAMALAYAN**.

- SECTION 1 *Municipal Permits and Licensing Officer.* Municipal Permits and Licensing Office shall ensure that the Ordinance be enforced;
- SECTION 2 No applicant for Business Permits shall be penalized if the delay in the issuance of Philhealth Clearance is due to the negligence, fault, sluggish or late action of the Philippine Health Insurance Corporation.
- SECTION 3 A representative from the Philippine Health Insurance Corporation must be present during the period of renewal of business permits.
- SECTION 4 *Effectively.* This Resolution/Ordinance shall take effect upon approval. Done in the Municipality of Pinamalayan this 27th day of March 2009.


