ORDINANCE NO. NO. 02-2008

"AN ORDINANCE REVERTING THE AMOUNT OF Php 209,839.50 REPRESENTING ACCOUNTS PAYABLE TO THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND".

By the powers vested upon the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, be it enacted in session assembled, that -

**Section I.** This Ordinance shall be known as Appropriation Ordinance No. 01 -08, Reversion of Accounts Payable to the Unappropriated balance of the General Fund.

**Section II. PURPOSE AND SCOPE:** It is hereby officially reverting Accounts Payable in the amount of Php 209,839.50 to augment deficient appropriations on Property, Plant & Equipment (Motor Vehicle) of the Office of the Municipal Mayor.

**Section III. APPROPRIATIONS:** The amount of Php 209,839.50 as certified by the Municipal Accountant and Municipal Treasurer as available for appropriations is hereby earmarked and/or appropriated for the following, to wit:

"AN ORDINANCE REVERTING THE AMOUNT OF Php 209,839.50 REPRESENTING ACCOUNTS PAYABLE TO THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND".

By the powers vested upon the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, be it enacted in session assembled, that -

**Section I.** This Ordinance shall be known as Appropriation Ordinance No. 01 -08, Reversion of Accounts Payable to the Unappropriated balance of the General Fund.

**Section II. PURPOSE AND SCOPE:** It is hereby officially reverting Accounts Payable in the amount of Php 209,839.50 to augment deficient appropriations on Property, Plant & Equipment (Motor Vehicle) of the Office of the Municipal Mayor.

RESOLUTION NO. 026-2008  
(ORDINANCE NO. 01-2008)

RESOLUTION ENACTING AN ORDINANCE AMENDING RESOLUTION NO. 70-95 ENTITLED RESOLUTION ENACTING AN ORDINANCE CREATING THE LOCAL COUNCIL OF WOMEN (LCW) AS THE FUNCTIONAL ARM OF THE LOCAL DEVELOPMENT COUNCIL OF WOMEN IN THE PHILIPPINES, DETERMINING ITS COMPOSITION AND PRESCRIBING ITS FUNCTIONS THEREOF.

WHEREAS, it is the policy of the Municipal Government of Pinamalayan to give equal access to all sector of the community to the decision-making process;

WHEREAS, the Municipal Government of Pinamalayan recognizes the important role of women in the nation building;

WHEREAS, maximizing the role of women in the community requires the creation of channels or venues for their active involvement just like the Local Council of Women (LCW);

WHEREAS, to fully realize however the good intentions of the Local Council of Women, it must be attuned to the changing signs of the times and some sections of the said ordinance creating the said council must be amended;

**NOW THEREFORE, BE IT ORDAINED**, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan that:

**Section I.** This Ordinance shall be known as "An Ordinance Amending Article III, Section A of Resolution No. 70-95 entitled" Resolution Enacting an Ordinance Creating the Local Council of Women (LCW) as the Functional Arm of the Local Development Council of Women and the Municipal Counterpart of the National Council of Women in the Philippines, Determining its Composition and Prescribing its Functions Thereof.

**Section II.** Article III, Section A of resolution No. 70-95, which states that:

"The Local Council of Women shall be composed of the Sangguniang Bayan Chairman of the Committee on Women, Family, Children, as Chairman; A lady Barangay Captain to be appointed by the ABC President as Vice-Chairman; the President of the Federation of Women Clubs or Organizations in Pinamalayan; a lady representative from all women NGO to be selected by the majority of the SB members, and the president of the marginalized women sector in Pinamalayan as members, Whose term of office shall be two (2) years."

*Is hereby amended to read as follows:*

**"The Local Council of Women (LCW) shall be composed of the Sangguniang Bayan Chairman of the Committee on Women, Family and Children; Social Services as Chairman; the First Lady of the Municipal Government as Co-Chairman; Lady Barangay Captain to be appointed by the ABC President as Vice-Chairman; and the following:**

- The Municipal Administrator
- The Municipal Planning Officer
- The Municipal Budget Officer
- The Municipal Social Welfare Officer
- The DILG Municipal Director
- The PNP Women's and Children's Desk
- The Municipal Health Officer
- President of an all-Women NGO
- President of Marginalized Women Sector, whose terms of office shall be three (3) years

**SECTION III.** Article V of Resolution No. 70-95 which is titled Effectivity Clause is hereby amended to be titled instead, as "Funding Allocation as follows:


**ARTICLE V. Funding Allocation** – "The Local Council of Women (LCW) shall be allocated annually with an amount of two hundred thousand (Php 200,000.00) pesos to be sourced from the GAD fund, to finance the operations of the Local Council of Women".

**Section IV.** The rest of the Articles shall be retained without amendment, except the number sequence of the succeeding Articles.


**Section V.** If any provision of this Ordinance shall be held invalid or unconstitutional the remaining provisions thereof not affected thereby shall remain in full force and effect.
