RESOLUTION ENACTING AN ORDINANCE MANDATING THAT ALL GOVERNMENT PROJECTS/CONSTRUCTIONS WHETHER NATIONAL, PROVINCIAL, MUNICIPAL AND BARANGAY LEVEL TO INSTALL BILLBOARD ON THEIR ON-GOING PROJECT IN THE LOCALITY OF PINAMALAYAN AND PROVIDING PENALTIES THEREOF.

WHEREAS, the Commission on Audit provides that government project/construction must install billboard in all on-going projects for identification and public information purposes;

WHEREAS, in the spirit of transparency, all government projects/constructions must exercise the fairness of information to the general public;

WHEREAS, this Ordinance is meant to protect the interest of all taxpayers nationwide, province wide and on the local level;

NOW THEREFORE:

On motion of Coun. Cobrado seconded by all members present-

RESOLVED as it is HEREBY RESOLVED to enact an Ordinance mandating that all government project/construction whether National, Provincial, Municipal and Barangay level to install billboard on their on-going project in the locality of Pinamalayan and providing penalties thereof.

ORDINANCE NO. 11-2008

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro.

SECTION I. TITLE: AN ORDINANCE MANDATING THAT ALL GOVERNMENT PROJECTS/CONSTRUCTIONS WHETHER NATIONAL, PROVINCIAL, MUNICIPAL AND BARANGAY LEVEL TO INSTALL BILLBOARD ON THEIR ON-GOING PROJECTS IN THE LOCALITY OF PINAMALAYAN AND PROVIDING PENALTIES THEREOF.

SECTION II. DEFINITION OF TERMS:

NATIONAL PROJECT – projects/constructions coming from National Government Agency (NGA) Government Own and Control Corporation (GOCC) and other government related offices.

PROVINCIAL, MUNICIPAL AND BARANGAY PROJECT – projects/constructions coming from the Local Government Unit (LGU).

BILLBOARD – advertisement made of wood or tarpaulin measuring 4 ft. x 8 ft.

SECTION III. All projects within the municipality of Pinamalayan covered by BAC irrespective of the amount shall be required to install billboard on their on-going projects.

SECTION IV. BILLBOARD RESPONSIBILITY:

Billboard shall carry or indicate the following informations:

Billboard shall be shouldered by the implementing office if it is by administration and by the contractor if the project is by-contract. Billboard will be installed within 15 days before the project commences.

SECTION V. PENAL PROVISION AND ADMINISTRATIVE PROVISIONS:

Any implementing agency whether national, provincial, municipal, barangay and project contractors or his authorized representative who shall violate, refuse or neglect to comply with any of the provisions promulgated under this ordinance shall be guilty of misdemeanor and upon conviction shall be fine amounting to Php 2,500.00.

The Office of the Municipal Engineer (MEO) thru its Chief of Office shall see to it that this ordinance is strictly implemented and serve notice of violation to the offender. Failure to install said billboard will mean temporary cessation of the project/construction with such time that this requirement is complied with. Fine shall be paid to the Municipal treasurers Office by the offender and thereafter proceed to MEO to show proof of payment.

SECTION VI. SEPARABILITY CLAUSE:

Any part or section hereof found to be unconstitutional for any reason, the section not affected by the declaration of invalidity shall remain in force and in effect.

SECTION VII. REPEALING CLAUSE:

All municipal laws, letter of implementation and executive orders inconsistent with the provision of this ordinance are hereby repealed and amended accordingly.


SECTION VIII. EFFECTIVITY CLAUSE:
