#### RESOLUTION NO. 086 - 2006

RESOLUTION ENACTING AN ORDINANCE AUTHORIZING THE MONTHLY PROCUREMENT OF PREPAID CELLPHONE CARDS TO ALL ASSISTANT MUNICIPAL GOVERNMENT DEPARTMENT HEADS AND IMMEDIATE SUPERVISORS AND/OR CHIEFS OF DIFFERENT DIVISIONS/SECTIONS TO IMPROVE THE COMMUNICATION SYSTEM AND FOR THE EXIGENCY OF THE SERVICE.

WHEREAS, the use of Cellular phone was authorized by the Commission on Audit (COA) in order tos\* facilitate the mode of communication among elective and appointive local officials of this municipality and undeniably, the advancement in communication technology provides better services and development in the LGU.

WHEREAS, while in the previous years, call card allowances have been provided among elective official and limited among Department Heads only, it had been taken to consideration that all assistant Department Heads as well as supervisors and/or chiefs of the different divisions/sections also have the dire need to avail such, which will definitely improve the communication link and facilitate effective delivery of services.

#### NOW THEREFORE:

On the motion of Hon. Dunhill Delmo seconded by all;

RESOLVED AS IT IS HEREBY RESOLVED to enact;

#### **ORDINANCE NO. 04 - 2006**

BE IT ENACTED by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, in session assembled that:

SECTION 1. This ordinance shall be known as "RESOLUTION ENACTING AN ORDINANCE AUTHORIZING THE MONTHLY PROCUREMENT OF PREPAID CELLPHONE CARDS TO ALL ASSISTANT MUNICIPAL GOVERNMENT DEPARTMENT HEADS AND IMMEDIATE SUPERVISORS AND/OR CHIEFS OF DIFFERENT DIVISIONS/SECTIONS TO IMPROVE THE COMMUNICATION SYSTEM AND FOR THE EXIGENCY OF THE SERVICE."

SECTION 2. DEFINITION OF TERMS. As used in this Ordinance, the term Assistant Municipal Department Head shall refer to all appointive local employees with salary Grace 22; while Immediate Supervisors/Chiefs of Différent Divisions/Sections shall refer shall refer to the HRMO, Licensing Officer III, Administrative Officer II, Designated Municipal Tourism Officer, and Designated Community e-Center Manager. Offices without existing Salary Grade 22 in their plantilla shall also be given this privilege based on the designated and recommended personnel as follows:

Office of the Mun. Registrar

Office of the Mun. Budget Officer

Office of the Mun. Accountant

MSWDO

Office of the Mun. Agriculturist

Office of the Mun. Engineer

Office of the Market Supervisor

- Administrative Aide VI, Item # 56

- Administrative Officer II

- Accountant III

- Agri. Technologist, Item #141

- Engineer I

- Administrative Officer V

SECTION 3. Incumbent of higher position who will be by-passed by the Department Head's designation in the grant of Prepaid Cellphone cards must issue a waiver that they are amenable with the designation made by their respective Department Heads.

SECTION 4. The monthly appropriation authorized for each official in the procurement of prepaid cellphone cards shall be as follows:

- a. SIX HUNDRED PESOS (Php 600.00) for Assistant Municipal Government Department Head.
- THREE HUNDRED PESOS (Php 300.00) for Immediate Supervisors/Chiefs of Divisions/Sections.
