RESOLUTION ENACTING AN ORDINANCE TRANSFERRING THE ROUTE OF ONE WAY FOR ALL VEHICLES FROM MANRIQUE STREET TO LEUTERIO DRIVE, THIS MUNICIPALITY.

Section I. this Ordinance shall be known as an Ordinance transferring the route of One Way for all vehicles from Manrique Street to Leuterio Drive, this Municipality.

Section II. All vehicles from Barangay Marfrancisco, using Mabini street going to the poblacion, are hereby required to turn right to Leuterio drive, then turn left at Madrid Boulevard to any other streets in the poblacion.

This new traffic regulation shall be observed from six o'clock in the morning (6:00 a.m.) to six o'clock in the afternoon (6:00 p.m.).
