ORDINANCE NO. 07-2005

AN ORDINANCE ESTABLISHING ANOTHER ADDITIONAL SCHOLARS TO THE PREVIOUS SCHOLARSHIP PROGRAM IN THE COLLEGE LEVEL FOR POOR BUT DESERVING STUDENTS RESIDING WITHIN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, that-

Section I. The Municipal Government of Pinamalayan shall be attending to the marked increase of the population of poor but deserving students within the Municipality.

Section II. The Municipality of Pinamalayan shall make another additional eight (8) scholars to the present Scholarship Program where there is a maximum of only sixteen (16) students.

The additional scholars shall be selected and added gradually per school year until the maximum of eight (8) additional scholars have been completed after four (4) years; as follows:

Year of Implementation	Present Total No. of Scholars	Grand Total No. of Scholars for the Year of Implementation
a) FIRST YEAR two (2) Scholars	sixteen (16)	eighteen (18)
b) SECOND YEAR two (2) Scholars	eighteen (18)	twenty (20)
c) THIRD YEAR two (2) Scholars	twenty (20)	twenty two (22)
d) FOURTH YEAR two (2) Scholars	twenty two (22)	twenty four (24)

Section III. This Ordinance shall take effect upon its approval.

Section IV. The Municipality of Pinamalayan shall consider the need of supporting additional scholars based on the increased income of the municipality.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, that-

Section I. The Municipal Government of Pinamalayan shall be attending to the marked increase of the population of poor but deserving students within the Municipality.

Section II. The Municipality of Pinamalayan shall make another additional eight (8) scholars to the present Scholarship Program where there is a maximum of only sixteen (16) students.


The additional scholars shall be selected and added gradually per school year until the maximum of eight (8) additional scholars have been completed after four (4) years; as follows:

c) THIRD YEAR two (2) Scholars	twenty (20)	twenty two (22)
d) FOURTH YEAR two (2) Scholars	twenty two (22)	twenty four (24)


Section III. This Ordinance shall take effect upon its approval.


Section IV. The Municipality of Pinamalayan shall consider the need of supporting additional scholars based on the increased income of the municipality.
