ORDINANCE NO. 07-2003

"AN ORDINANCE APPROVING THE AMOUNT OF P693,985.00 REPRESENTING THE MUNICIPALITY'S SHARE IN THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND"

By the powers vested by law upon the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, be it enacted in session assembled

-THAT-

Section I. TITLE: This Ordinance shall be known as Appropriation Ordinance No. 04-2003.

Section II. SCOPE & OBJECTIVES: This Ordinance shall augment the funding requirements of devolved functions as provided for in Oversight Committee Resolution No. 2002-01 dated January 9, 2002.

Section III. SOURCE OF FUNDS: The principal source of fund for this Appropriation Ordinance shall be:
