RESOLUTION ENACTING AN ORDINANCE AMENDING SECTIONS 5, 7 & 13 OF ORDINANCE NO. 04-98 OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, Ordinance No. 04-98 (Liquefied Petroleum Gas Regulation Ordinance) was enacted by the Sangguniang Bayan on July 13, 1998;

WHEREAS, the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, deems it just and proper to amend Sections 5, 7 & 13 hereof for the benefit and welfare of the people and the concerned LPG dealers;

NOW THEREFORE:

On motion of Councilor Corazon Fabreag-Agarap and duly seconded by Councilor Patricio J. Ocampo -

RESOLVED as it is HEREBY RESOLVED to enact an Ordinance amending Sections 5, 7 & 13 of Ordinance No. 04-98.

ORDINANCE NO. 2000-01

AN ORDINANCE AMENDING SECTIONS 5, 7 & 13 OF ORDINANCE NO. 04-98 OF PINAMALAYAN, ORIENTAL MINDORO.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro in session assembled that -


Section I. This Ordinance shall be known as LPG Regulation Ordinance No. 2, series of 2000;

Section II. Sections 5, 7 & 13 of Ordinance No. 04-98 are hereby amended and shall now be read as:

- a) Second sentence of Section 5 - " Sale or barter of Liquefied Petroleum Gas (LPG) may only be allowed in residential Zones wherein mixed land use is allowed, provided that the establishment shall not be allowed to store more than twenty (20) LPG cylinders at any one time ",
- b) Section 7 - " No person or establishment engaged in transporting or conveying of LPG shall be allowed to transport or convey for commercial purposes LPG within the Municipality of Pinamalayan, except those who will be passing only and will deliver/sell/unload to other municipalities, unless a business permit has been obtained for the said specific purposes",
- c) Section 13 - Transitory provision - "All persons or establishments adversely affected by this Ordinance shall be given a period of one (1) year after the date of effectivity of this Ordinance within which to comply with all the provisions hereof".

Section III. This Ordinance shall take effect upon approval.
