ORDINANCE NO. 10 -96

AN ORDINANCE REQUIRING ALL PUBLIC CONVENIENCE VEHICLES PLYING WITHIN THE JURISDICTION OF PINAMALAYAN TO HAVE TRASH CANS/WASTE BASKETS IN THEIR VEHICLES FOR THE USE OF PASSENGERS.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro that -

Section I. Title. This ordinance shall be known as Ordinance requiring all public convenience vehicles plying within the jurisdiction of Pinamalayan to have trash cans/waste baskets for the use of passengers.

Section II. Definition of Terms as used in this Ordinance :

1. Public Convenience Vehicles - shall mean buses, jeepneys, tricycles, tri-bikes, horse-drawn vehicles, or any vehicle conveying paying passengers.
2. Trash Cans/Waste Baskets - shall mean any container that will hold solid or liquid waste materials.

Section III. Regulated Act and Inspection - No public convenience vehicles shall be allowed to ply within the municipal jurisdiction without the said waste container; two for buses, one for jeepney, tri-bike, tricycle and calesa, and the like.

The Local Philippine National Police and other deputized agencies are directed by this ordinance to religiously inspect the presence and absence of waste container.

Section IV. Penalty Clause :

- a) A driver and a conductor who violates this said ordinance shall be meted separately with a fine of not less than three hundred pesos (P300.00) but not more than one thousand pesos (P1,000.00) or imprisonment of not less than six (6) hours but not more than three (3) days) or both at the discretion of the court.
- b) The operators of jeepneys and buses will be meted separately with similar fine and penalty.

Section V. Repealing Clause. All ordinances, rules and regulations or parts thereof whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section VI. Effectivity Clause. This Ordinance shall take effect upon its approval.
