RESOLUTION NO. 48-A-96

RESOLUTION ENACTING AN ORDINANCE AMENDING THE SECTIONS 6 AND 9 OF ORDINANCE NO. 16-95 OF THE TFRB GUIDELINES PARTICULARLY ON THE PAYMENT OF FRANCHISE FEES AND OTHER SPECIFIC FEES BY THE OPERATORS OF MOTORIZED TRICYCLES IN PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, the TFRB guidelines are meant to regulate and improve the operation of motorized tricycles in the municipality of Pinamalayan that will be fair both for the tricycle operators and the municipal government of Pinamalayan;

WHEREAS, Section 9 of Ordinance No. 16-95 under the heading Time and Manner of Payment have caused confusion for it limits the payment of registration fees and other specific fees only to the first week of January;

WHEREAS, Section 6 under the heading Modified Franchise Fee and Other Specific fees, failed to include the fees for the registration plates;

WHEREAS, in view of the foregoing, Sections 6 and 9 of Ordinance No. 16-95 need to be amended immediately;

NOW THEREFORE :

Upon motion of Honorable SB Member Arnel G. Abrenica and Honorable SB Member Susan F. Cobrado and seconded by all -

Be it RESOLVED as it is HEREBY RESOLVED to amend Sections 6 and 9 of the TFRB guidelines on the Payment of Franchise Fee and other Specific Fees by the Operators of Motorized Tricycles in Pinamalayan, Oriental Mindoro.

ORDINANCE NO. 12-96

AN ORDINANCE AMENDING SECTIONS 6 AND 9 OF ORDINANCE NO. 16-95 OF THE TFRB GUIDELINES PARTICULARLY ON THE PAYMENT OF FRANCHISE FEES AND OTHER SPECIFIC FEES BY THE OPERATORS OF MOTORIZED TRICYCLES IN PINAMALAYAN, ORIENTAL MINDORO.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro that :

Section 1. Sections 6 and 9 of Ordinance No. 16-95 are hereby amended to read as follows :

Section 6. Modified Franchise Fees and Other Charges

- a) The annual franchising fee and other fees in the granting of franchise and regulation of tricycle operation are as follows :

a.1. For Operators only

Section 9. Time and Manner of Payment. The new applicant shall pay their registration fees, tricycle's operator's permit and other specific fees on the day of the acquisition of the units, and shall be required to renew on the same day and month of their previous registration. Those applicants, however who have paid the TOP for the year 1996 during the month of January shall hereby be subjected for renewal based on the previous stipulated provision of Ordinance No. 16-95. The grace period for payment of the said fees as stipulated in Ordinance No. 16-95 shall still apply.

Section 2. All local laws, executive orders, rules, regulations and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 3. This ordinance shall take effect upon the approval.
