RESOLUTION NO. 73-95

RESOLUTION ENACTING AN ORDINANCE ESTABLISHING THE MUNICIPAL ELDERLY COUNCIL FOR SENIOR CITIZENS AND FOR OTHER PURPOSES.

WHEREAS, Section (5) (XVII) of the Local Government Code of 1991 provides that the Sangguniang Bayan shall establish a municipal council for the elderly;

WHEREAS, Senior citizens have an important role in the development of the municipality;

WHEREAS, the creation of coordinating body would provide a vehicle for the systematic planning and deliberation of municipal programs for senior citizens;

NOW THEREFORE :

On motion of Honorable SB Member Virgilio C. Yumang and seconded by all -

RESOLVED as it is hereby resolved to enact an ordinance establishing the Municipal Elderly Council for Senior Citizens and for other purposes.

ORDINANCE NO. 08-95

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, that -

Section I. Creation of the Municipal Council for Senior Citizens. There is hereby created a Municipal Council for Senior Citizens which shall be composed of the Municipal Mayor, as Chairman, the most senior member of the Sangguniang Bayan as Vice Chairman and the following as members : the duly elected President of the Municipal Association of Senior Citizens and the Municipal Social Welfare Development Officer.

Section 2. Powers and Functions - In line with its primary responsibility, the council shall exercise the following powers and functions, to wit :

1. Coordinate, promote and monitor municipal programs for senior citizens.
2. Coordinate with national government agencies and non-governmental organizations for the promotion of the welfare of senior citizens.
3. Propose legislative measures for senior citizens to the Sangguniang Bayan.
4. Solicit and accept donations and monetary contributions from local and foreign sources for the purposes of implementation/financing the program of the council.
5. Formulate and implement such rules and regulations as may be necessary, to administer the provisions of this resolution.
6. Coordinate with the municipal chapters of senior citizens regarding the grant of twenty percent (20%) discount from all establishments relative to utilization of transport services, hotels, drugstores and similar lodging establishments and restaurants.
7. Harness and utilize special skills, talents of physically and mentally disable citizens to be of service to the community in time of natural and man made calamities like typhoons, earthquakes, fires, etc.
8. Lecture on specialized field like agriculture, health, environmental protection, moral recovery program and sports and cultural activities.

Page Two of Resolution No. 73-95 enclosing Ordinance No. 08 -95 :


