RESOLUTION NO. 100-2023

A RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF PINAMALAYAN REPRESENTED BY THE MUNICIPAL MAYOR, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO AND ITS OTHER COMPONENT LOCAL GOVERNMENT UNITS (LGUs) FOR THE INTER LGU COOPERATION AND FOR THE IMPROVEMENT AND SUSTAINABILITY OF AN EFFICIENT AND EFFECTIVE HEALTH CARE DELIVERY SYSTEM.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom for its efficient and effective governance, and those which essential to the promotion of the general welfare pursuant to the Local Government Code of 1991;

WHEREAS, it is the policy of the State to protect and promote the right to health of all Filipinos and instill health consciousness among them by virtue of R.A. 11223 also known as Universal Health Care (UHC) Act of 2019;

WHEREAS, the Inter Cooperation aims to ensure and strengthen the collaborative linkages between the province and its component LGUs through the generation, mobilization, and allocation of essential resources for the improvement and sustainability of an efficient and effective health care delivery system;

WHEREAS, the Municipal Government of Pinamalayan shall formulate and implement an integrated municipal health plan; implement programs and projects of the integrated health plan; implement the regulatory measures formulated at the national level; propose and implement other needed regulatory measures for the municipality; manage and finance the Municipal Health Office (MHO), Barangay Health Stations (BHS), and Hospitals owned by the LGU; promote coordination among health related sectors in activities for health promotion and protection at the municipal and component city level including the private sector and non-government organizations; and improve and maintain the road network to facilitate access and referral to and from the BHS, RHU, and the core referral hospital;

WHEREAS, this august body realizes the significance of the Inter LGU Cooperation and Health Care Delivery System towards the enhancement of the delivery of health services; hence, a resolution for authority to the local chief executive to enter into a MOA for the aforementioned purpose is hereby executed.
