RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE -
BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA-BFAR) MIMAROPA FOR THE
PROVISION OF FUEL SUBSIDY TO THE TARGET BENEFICIARIES IN THE MUNICIPALITY
OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, under Section 2 (e) of Republic Act 8550 as amended by Republic Act No. 10654 or the Philippine Fisheries Code of 1998 as amended, it is the declared policy of the State to provide support to the fishery sector, primarily to the municipal fisher folk, including women and youth sectors, through appropriate technology and research, adequate financial, production, construction of post-harvest facilities, marketing assistance, and other services;

WHEREAS, under the Philippine Fisheries Code of 1998 as amended, the Bureau of Fisheries and Aquatic Resources under the Department of Agriculture is the principal government agency tasked with providing support to the fishery sector primarily through livelihood and financial support, technology, research, production, construction of post-harvest facilities, marketing assistance, and other services;

WHEREAS, last 28 February 2023, an oil tanker known as the M/T PRINCESS EMPRESS sank off the coast of Balingawan Point, Naujan, Oriental Mindoro resulting in an oil spillage in the coastal municipalities of Oriental Mindoro causing devastation of coastal marine ecosystems and disruption in the livelihood of fisherfolks who primarily rely on the sea for sustenance;

WHEREAS, in order to alleviate the situation, the DA-BFAR will provide fuel subsidy to more or less Four Thousand (4,000) municipal and commercial fishing vessels based on the listing under the Municipal Fishing Vessel and Gears Registration System of BoatR and the Commercial Fishing Vessel and Gear Registration;

WHEREAS, pursuant to Special Provision No. 6 of the F.Y 2023 General Appropriations Act (GAA), an amount of Twelve Million Pesos (Php 12,000,000.00) shall be allocated to the Province of Oriental Mindoro as fuel subsidy for those owners of registered municipal and commercial fishing vessels who are adversely affected by the oil spill;

WHEREAS, the Municipal Government of Pinamalayan, is mandated under Republic Act No. 7160 or the Local Government Code of 1991, to formulate and develop projects and programs which aimed at ensuring the rehabilitation of vital economic activities such as those belonging to the fisheries sector;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Local Chief Executive to Enter into Memorandum of Agreement with the Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR) MIMAROPA for the provision of fuel subsidy to the target beneficiaries in the Municipality of Pinamalayan, Oriental Mindoro
