WHEREAS, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned pursuant to Local Government Code of 1991;

WHEREAS, the Municipal Government of Pinamalayan desires to avail services of Diona's Catering Services for the Venue Set-up (Package deal) for various events in celebration of 107th Founding Anniversary and 24th Bahaghari Festival of this Municipality;

WHEREAS, Diona's Catering Services, engaged in the business of providing venue set-up for various events, is willing to provide services to the Municipal Government of Pinamalayan in the amount of Five Hundred Ten Thousand Six Hundred Sixty Five Pesos (Php 510,665.00);

WHEREAS, the Municipal Government of Pinamalayan and Diona's Catering Services are amenable with the terms and conditions set forth in the contract, copy of which shall form as integral part of this Resolution;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Local Chief Executive, Hon. Aristeo Apasan Baldos, Jr. to enter into Contract of Service with Diona's Catering Services for the Venue Set-Up (Package Deal) for various events during Pinamalayan 107th Founding Anniversary and 24th Bahaghari Festival Celebration.
