WHEREAS, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned pursuant to Local Government Code of 1991;

WHEREAS, the Municipal Government of Pinamalayan desires to avail the services of BXJ Enterprises for the provision of Sound System and LED Wall (package deal) for various events in celebration of 107th Founding Anniversary and 24th Bahaghari Festival of this Municipality;

WHEREAS, BXJ Enterprises, engaged in the business of providing sound system and LED wall for various events, is willing to provide services to the Municipal Government of Pinamalayan in the amount of Eight Hundred Twenty Thousand Pesos (Php 820,000.00);

WHEREAS, the Municipal Government of Pinamalayan and BXJ Enterprises are amenable with the terms and conditions set forth in the contract, copy of which shall form as integral part of this Resolution;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Local Chief Executive, Hon. Aristeo Apasan Baldos, Jr. to enter into Contract of Service with BXJ Enterprises for the Sound System and LED Wall (Package Deal) for various events during Pinamalayan 107th Founding Anniversary and 24th Bahaghari Festival Celebration.
