RESOLUTION NO. 030-2023

RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION OF HABITAT PINAMALAYAN HOMEOWNERS' ASSOCIATION, INC. (HAPI-HOA, INC) AS A NON-GOVERNMENT ORGANIZATION OF THIS MUNICIPALITY.

WHEREAS, Section 34, Article III, Book I of RA 7160 states that the Local Government Units shall promote the establishment and operation of people's and a non-government organization and make them active partners in the pursuit of local autonomy;

WHEREAS, Section 108, Article III, Book I of RA 7160 mandates that the Local Sanggunian concerned shall accredit non-government organizations subject to such criteria as may be provided by law;

WHEREAS, the association has submitted the following documents in support for their application, to wit:

1. Letter of application for accreditation;
2. Accomplished Application Form for Accreditation;
3. Certificate of Registration from the Housing and Land Use Regulatory Board with Articles of Incorporation & Constitution and By-Laws;
4. List of current Officers and Members;
5. Annual Accomplishment Reports;
6. Financial Statements;
7. Certification of the concerned Barangay Chairman wherein the association is presently operating; and
8. Minutes of meeting.

WHEREAS, the Sanggunian has reviewed the aforementioned documents and verified the authenticity thereof;

WHEREAS, this accreditation will expire on June 30, 2025, however if the organization is found to be engaging in any unlawful activities or is being used for personal gains or interest of the officers/members, the accreditation could be earlier withdrawn by this august body.

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro to approve the Application for Accreditation of Habitat Pinamalayan Homeowners' Association, Inc. (HAPI-HOA, INC) as a Non-Government Organization of this Municipality.
