RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH PINAMALAYAN MARITIME FOUNDATION & TECHNOLOGICAL COLLEGE, INC. (PMFTCI) THROUGH MR. ANGELITO S. KING, COLLEGE PRESIDENT TO ACCEPT STUDENTS AS TRAINEES IN SUPPORT TO THEIR ON-THE-JOB TRAINING PROGRAM.

**WHEREAS**, Higher Education Institution (HEI) offers programs that require students to undergo on-the-job training (OJT) in public or private offices as part of academic requirement for graduation in order to expose them in actual work situations as a means to enhance their formal training;

**WHEREAS**, PMFTCI through Mr. Angelito S. King, College President wishes to avail the services of the Municipal Government of Pinamalayan in providing a quality On-the-Job Training (OJT) for their students;

**WHEREAS**, the Municipal Government of Pinamalayan agrees with PMFTCI to be a training venue of their students for the necessary exposure on activities related to their areas of specialization and chosen field;

**WHEREAS**, Sec. 22 (c) of the Local Government Code of 1991 provides that *no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned*; hence, this resolution of authorization is hereby executed.

RESOLUTION NO. 034-2023

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH VARIOUS PUBLIC AND PRIVATE SECONDARY SCHOOLS WITHIN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO FOR THE CONDUCT OF WORK IMMERSION PROGRAM IN THE MUNICIPAL GOVERNMENT OF PINAMALAYAN.

**WHEREAS**, DepEd was tasked to implement the K to 12 Program, essentially adding two (2) years of specialization within the Basic education System pursuant to RA 10533 (Enhanced Education Act of 2013) and the DepEd designed the implementation of RA 10533 within the framework of increased community involvement in the learner's experience;

**WHEREAS**, Work Immersion Program is in consonance to the formal curriculum of Senior High School under K to 12 Basic Education System of the Department of Education (DepEd);

**WHEREAS**, this is one of the course requirements for graduation that the Senior high School students have to undergo through the Work Immersion Partnership with the various agency and establishment as the venues for the training;

**WHEREAS**, various Public and Private Secondary Schools within the municipality wish to avail the services of the Municipal Government of Pinamalayan in providing a quality Work Immersion for their students;

**WHEREAS**, by accommodating Work Immersion in this local government unit, their students will be able to enhance their technical knowledge and skills; learn to interact with other students and professionals; and eventually be exposed to activities related to their areas of specialization and chosen field.


