RESOLUTION NO. 043-2023

A RESOLUTION APPEALING TO MR. MARK T. LAPID, CHIEF OPERATING OFFICER, TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA), FOR FUNDING ASSISTANCE TO SUPPORT THE PROPOSED PROJECT "INSTALLATION OF MODULAR DOCKS" IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO AMOUNTING TO FIVE MILLION PESOS (PHP 5,000,000.00).
