RESOLUTION NO. 049-2023

RESOLUTION APPROVING THE APPLICATION FOR THE RENEWAL OF ACCREDITATION OF PALAYAN PINAMALAYAN FARMERS ASSOCIATION AS A NON-GOVERNMENT ORGANIZATION AND CIVIL SOCIETY'S ORGANIZATION OF THIS MUNICIPALITY.

WHEREAS, Section 34, Article III, Book I of RA 7160 states that the Local Government Units shall promote the establishment and operation of people's non-governmental organizations to become an active partner in the pursuit of local autonomy; **WHEREAS**, Section 108, Article III, Book I of RA 7160 mandates that the Local Sanggunian concerned shall accredit Civil Society Organizations subject to such criteria as may provide by the law;

WHEREAS, the aforementioned organization has submitted/complied with the necessary requirements stipulated in the checklist of documentary requirements for Cooperatives, PO's, NGO's and CSO's for accreditation of the Sangguniang Bayan;

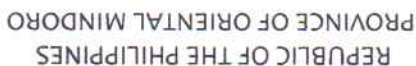
WHEREAS, the association has submitted the following documents in support for their application, to wit;

1. Letter of Intent/Board Resolution;
2. Accomplished Application form for Accreditation;
3. Certificate of Registration from the Department of Labor and Employment (DOLE) with Articles of Incorporation and By-Laws;
4. List of Current Officers and Members with membership contribution and Community Tax Certificate duly certified by the Secretary and President of the Association;
5. Annual Accomplishment Report for 2022;
6. Current Financial Statement;
7. Certificate of concerned Barangay Chairman wherein the Association is presently existing and operating;
8. Minutes of the meeting of the last General assembly showing the result of the Election of Officers.

WHEREAS, the Sanggunian has reviewed the aforementioned documents and verified the authenticity thereof;

WHEREAS, this accreditation will expire on June 30, 2025, however, if the organization is found to be engaging in any unlawful members, the accreditation could be withdrawn by this august body, even before the period of expiration;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro to approve the application for the renewal of accreditation of Palayan Pinamalayan Farmers Association as a Non-Government Organization and Civil Society's Organization of this municipality.
