RESOLUTION NO. 052-A-2023

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DR. CARL BALITA REVIEW CENTER (CBRC) FOR THE CONDUCT OF FREE REVIEW PROGRAM FOR EMPLOYEES OF THE LOCAL GOVERNMENT UNIT (LGU) OF PINAMALAYAN.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare in consonance to Sec. 16 of the Local Government Code of 1991;

WHEREAS, the same act stipulates that the Local Chief Executive may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law ordinance upon authorization by the sangguniang bayan;

WHEREAS, Dr. Carl Balita Review Center (CBRC) is eager and able to provide Free Review Program for employees of this local government unit in preparation for the Civil Service Examination to be held on March 26, 2023 and shall exert their best efforts and services to deliver quality classes;

WHEREAS, the Municipal Government of Pinamalayan accepts the offer of the RCBC for the best interest of the employees;

WHEREAS, the Municipal Government of Pinamalayan and the CBRC are amenable with the terms and conditions set forth in the MOA, copy of which shall form as integral part of this Resolution;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Local Chief Executive, Hon. Aristeo Apasan Baldos, Jr. to enter into a Memorandum of Agreement (MOA) with Dr. Carl Balita Review Center (CBRC) for the conduct of Free Review Program for Employees of the Local Government Unit (LGU) of Pinamalayan.
