RESOLUTION NO. 059-2023

RESOLUTION ADOPTING THE COMMITTEE REPORT RENDERED BY THE COMMITTEE OF THE WHOLE PERTAINING TO THE RECOMMENDATION ON THE ADMINISTRATIVE CASE FILED BY MS. VERONICA A. GEBANA AGAINST BARANGAY CAPTAIN RANDY H. MOREDO OF BARANGAY ANOLING, PINAMALAYAN, ORIENTAL MINDORO DOCKETED AS SB CASE NO. 22-01.

WHEREAS, a verified complaint was filed by Ms. Veronica A. Gebana on June 14, 2022 against Barangay Captain Randy H. Moredo of Barangay Anoling, this municipality allegedly for Abuse of Authority docketed as SB Case No. 22-01;

WHEREAS, the respondent Barangay Captain Randy H. Moredo submitted his verified answer on July 7, 2022;

WHEREAS, during the preliminary conference conducted on February 06, 2023 by the Committee of the Whole, both parties agreed to submit their position paper within ten (10) days thereof or not later than February 16, 2023;

WHEREAS, only the respondent, Barangay Captain Randy H. Moredo submitted his position paper on February 16, 2023;

WHEREAS, upon evaluation of the evidence presented by both parties, the Committee as contained in the Committee Report No. 23-13 found out hereunder findings:

1. That based on the protocol, only the residents shall be accommodated during the first day of registration in Barangay Anoling, and on the second day the PSA team may allow residents from another barangay to apply if the given quota has been reached. The role of the barangay officials is to help the team in determining if the applicants are residents of their barangay and Ms. Veronica A. Gebana, a resident of Barangay Palayan, was not accommodated on the first day of the registration being exclusive to residents of Brgy. Anoling consistent with the established procedure.

2. That Respondent Moredo in determining who are the residents of Barangay Anoling that are eligible to avail the National ID Registration Program on the first day of the activity is actually performing his duty to render support to the PSA team.

WHEREAS, the body affirmed and concurred with the recommendation submitted by the aforementioned Committee to dismiss the case absence of substantial evidence that the act committed by the respondent constitutes Abuse of Authority and Neglect of Duty;

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Oriental Mindoro to adopt the committee report rendered by the Committee of the Whole pertaining to the decision on the administrative case filed by Ms. Veronica A. Gebana against Barangay Captain Randy H. Moredo of Barangay Anoling, Pinamalayan, Oriental Mindoro docketed as SB Case No.

RESOLVED FURTHER that a certified copy of this Resolution be given to the parties involved in the case herein, Office of the Municipal Mayor and MLGOO.
