RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO CONTRACT AGREEMENT WITH THE WINNING BIDDER FOR THE IMPLEMENTATION OF THE PROJECT "CONSTRUCTION OF THREE CLASSROOM BUILDING (DR. ARISTEO V. BALDOS, SR., PAPANDAYAN HIGH SCHOOL)" AMOUNTING TO FOUR MILLION FIVE HUNDRED THOUSAND (PHP4,500,000.00) PESOS.

WHEREAS "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare" pursuant to Section 16 of RA 7160 also known as Local Government Code of 1991;

WHEREAS Section 444 (1) (vi) of the same code states that the Local Chief Executive shall represent the municipality in all its transactions and sign on its behalf all bonds, contracts and obligations, and as such other documents made pursuant to law or ordinance upon authorization by the Sangguniang Bayan;

WHEREAS the project "Construction of Three Classroom Building (Dr. Aristeo V. Baldos, Sr., Papandayan High School)" is located at Barangay Papandayan, this municipality with a budget allocation from 20% Municipal Development Fund 2023 amounting to PHP4,500,000.00;

WHEREAS, this august body recognizes that basic infrastructures and facilities spur economic growth and sustainable development, hence, the resolution for authority to the local chief executive to enter into contract agreement for the aforesaid project is hereby executed for the best interest of the public.

UNANIMOUSLY APPROVED this 6th day of March 2023 at Pinamalayan, Oriental Mindoro on motion of Hon. Angelo Marlo D. Madrid seconded by all Sangguniang Bayan Members present.
