RESOLUTION ADOPTING AND APPROVING MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRMC) RESOLUTION NO. 03-A-2023, ENTITLED: "RESOLUTION RECOMMENDING FOR THE REPROGRAMMING OF THE UNUTILIZED BALANCE UNDER THE CONTINUING LEGISLATIVE APPROPRIATIONS (CONLA) WITH A TOTAL AMOUNT OF EIGHT MILLION NINE HUNDRED NINETY-FIVE THOUSAND THREE HUNDRED THIRTY-FIVE AND 10/100 (PHP8,995,335.10) PESOS AND HEREBY APPROPRIATING THE SAME TO THE IDENTIFIED PRIORITY PROJECTS, PROGRAMS AND ACTIVITIES".

WHEREAS, provided in the Republic Act 10121 also known as the Philippine Disaster Risk Reduction and Management Act of 2010, under Section 21, Local Disaster Risk Reduction and Management Fund (LDRRMF), Unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMCs within the next five (5) years;

WHEREAS, the amount of Php8,995,335.10 from the Continuing Legislative Appropriation in Property, Plant and Equipment of MDRRMF of the Municipality is certified by the Municipal Accountant as unutilized balance of MDRRMF free from any obligation;

WHEREAS, the total estimated cost for the above cited procurement of 13 Rescue Vehicles amount to Php12,350,000.00;

WHEREAS, the amount of Php8,995,335.10 from CONLA be appropriated for the procurement of 13 units Rescue Vehicle intended for different Barangays of the municipality;

WHEREAS, the MDRMC through MDRMC Resolution No. 03-2023 recommended that the balances savings from Trust Fund be used to augment the funds from CONLA for the procurement of Rescue vehicles;

WHEREAS, the Sangguniang Bayan firmly believes the importance of aforementioned program for the promotion of the welfare of our constituents;
