RESOLUTION NO. 067-2023

RESOLUTION DECLARING THE ENTIRE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO UNDER THE STATE OF CALAMITY DUE TO OIL SPILL WITHIN THE MUNICIPAL WATER CAUSED BY THE CAPSIZED OIL TANKER MT PRINCESS EMPRESS AT NAUJAN, ORIENTAL MINDORO.

WHEREAS, Section 447 (a) of RA 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sect. 16 of this code;

WHEREAS, Municipal Disaster Risk Reduction and Management Council (MDRRMC) recommends the declaration of Municipality of Pinamalayan under the State of Calamity due to oil spill within the municipal water and affected inhabitant caused by the Capsized Oil Tanker Mt. Princess Empress at Naujan, Oriental Mindoro under MDRRMC Resolution No. 04-2023;

WHEREAS, the contamination of the municipal water, Marine protected areas, as well as the marine resources following the oil spill can lead to a possible wide spread environmental and health hazard all throughout the nine coastal barangays of the municipality of Pinamalayan;

WHEREAS, this maritime unfortunate incident is detrimental to public health and economic wellbeing of the residents, most especially the fisherfolks whose livelihood was adversely affected;

WHEREAS, the Municipal Government of Pinamalayan is committed in protecting its constituents in most cases in time of calamities wherein its declaration is an appropriate tool in the proper implementation of the programs of the municipality to mitigate the socio-economic impact caused of oil spill;
