RESOLUTION ADOPTING AND APPROVING MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 05-2023 ENTITLED: "RESOLUTION RECOMMENDING FOR THE REPROGRAMMING OF THE UNUTILIZED BALANCES UNDER THE TRUST FUND WITH A TOTAL AMOUNT OF ONE MILLION (PHP1,000,000.00) PESOS AND HEREBY APPROPRIATING THE SAME TO THE PERSONAL PROTECTIVE EQUIPMENT UNDER THE MEDICAL SUPPLIES AND LABORATORY EXPENSES TO MITIGATE THE EFFECT OF OIL SPILL IN THE MUNICIPALITY".

WHEREAS, provided in the Republic Act 10121 also known as the Philippine Disaster Risk Reduction and Management Act of 2010, under Section 21, Local Disaster Risk Reduction and Management Fund (LDRRMF), *Unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMCs within the next five (5) years.*

WHEREAS, Section 21 of RA 10121 provides that upon the recommendation of the Local Disaster Risk Reduction and Management Office (LDRRMO) and approval of the local Sanggunian, the LDRRM Council may transfer the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk reduction work which are declared under the state of calamity;

WHEREAS, the Sangguniang Panlalawigan thru Resolution No. 6290-2023 dated March 6, 2023 declared the 78 Coastal Barangays from 9 Municipalities (Naujan, Pola, Pinalamayan, Gloria, Bansud, Bongabong, Roxas, Mansalay & Bulalacao) in the Province of Oriental Mindoro affected by oil spill from MT Princess under State of Calamity;

WHEREAS, the Sangguniang Bayan likewise declared State of Calamity thru Resolution No. 067-2023 dated March 13, 2023;

WHEREAS, in order to address the immediate needs of the municipality, the aforementioned amount from the Trust Fund shall be appropriated for the procurement of personal protective equipment specifically the medical supplies and laboratory expenses;

WHEREAS, the Sanggunian Bayan firmly believes the importance of aforementioned program for the promotion of the welfare of our constituents;

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Council (MDRRMC) Resolution no. 05-2023, entitled: "Resolution recommending the reprogramming of the Unutilized Balances under the Trust Fund with a total amount of One Million (Php1,000,000.00) pesos and hereby appropriating the same to the personal protective equipment under the Medical Supplies and Laboratory Expenses to mitigate the effect of oil spill in the municipality".
