RESOLUTION GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO A. BALDOS, JR. TO ISSUE SPECIAL PERMIT TO OPERATOR OF A DULY LICENSED COCKPIT ON LEGAL AND OTHER ALLOWABLE DAYS HOLDING COCKFIGHTS FOR THE PURPOSE AS HEREIN STIPULATED.

WHEREAS, PD 449 otherwise known as “*Cockfighting Law of 1974*” and other pertinent laws apply to all matters regarding the operation of cockpits in this municipality;

WHEREAS, the holding of cockfights shall conform to all applicable provisions stated in Municipal Ordinance No. 01-2020, entitled: *An Ordinance regulating cockfighting, the establishment, operation and maintenance of cockpits and the breeding of gamecocks in the Municipality of Pinamalan, Oriental Mindoro*;

WHEREAS, Section 13 of *Municipal Ordinance No. 01-2020 on Time and Place of Holding Cockfights*, explicitly states that cockfights may be held only in licensed cockpits during Sundays and legal holidays, not otherwise prohibited in the same Ordinance; That, no cockfighting shall be held during other days of the week and the following legal holidays, to wit:

- Maundy Thursday
- Good Friday
- Philippine Independence Day (June 12)
- All Saints Day (November 1)
- National Heroes Day (November 30)
- Election Day, Plebiscite of Referendum Day
- Registration Day for such Referendum Day or Plebiscite Day
- Rizal Day (December 30)

WHEREAS, Section 14 of Municipal Ordinance No. 01-2020, provides that special cockfighting shall only be allowed on the following occasions upon authority by the Sangguniang Bayan; That, no cockfighting whether regular or special hack fights, including derby, shall be allowed in one cockpit oftener than three (3) times a week;

- a) On occasion of the founding anniversary/town fiesta for not more than three (3) consecutive days and not more than once a year;
- b) Three (3) consecutive days during municipal, agricultural, commercial or industrial fair, carnival or exposition for a similar period of time;
- c) For entertainment of foreign dignitaries, tourists or returning Filipinos commonly known as Balikbayans; Provided that, only one (1) permit may be issued for the same purpose in a calendar year by the Sangguniang Bayan for a period not exceeding three (3) consecutive days;
- d) For the support of local fund-raising campaign for charitable purposes as may be authorized by the Municipal Mayor in consultation with the Municipal Social Welfare and Development Office;
- e) For fund-raising purposes of barangay founding anniversary/barangay fiesta and other purposes.

WHEREAS, the grant of authority to the LCE shall be effective on April 01, 2023 and valid until June 30, 2023 for a period of 3 months;

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Oriental Mindoro to grant authority to the Local Chief Executive, Hon. Aristeo A. Baldos, Jr. to issue Special Permit to operator of a duly licensed cockpit on legal and other allowable days holding cockfights for the purpose as herein stipulated.

Resolved further, that copies of this resolution be furnished to the Business Permits and Licenses Office (BPLO).
