RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO CONTRACT OF SERVICE WITH WEB.COM.PH INC. FOR PROVISION OF UPGRADED WEB HOSTING SERVICES OF THE OFFICIAL WEBSITE OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, Every local government unit, as a corporation, shall have the power to enter into contracts subject to the limitations provided in the Local Government Code that no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, local government units shall exercise other functions towards effective provision of the basic services and facilities intended primarily to serve the needs of the residents of the municipality;

WHEREAS, the Municipality of Pinamalayan is in need of upgraded web hosting services for the Municipality's official website (www.pinamalayan.gov.ph);

WHEREAS, WEB.COM.PH INC is a web hosting entity that possesses the qualifications, experience, technical knowledge and skills, and with legal capacity to enter into agreement for web hosting and signified their intention to provide such services;

WHEREAS, the web hosting contract services needed by this municipality shall be in effect for the period covering June 01, 2023 to May 31, 2024 in consideration of Sixty Thousand Pesos (Php 60,000.00) comprising of 100 GB Disk Space with Unlimited Domains and Unlimited Bandwidth representing Gold Reseller Plan, together with the necessary technical assistance and other support services;

WHEREAS, the Municipal Government of Pinamalayan and WEB.COM.PH INC are amenable with the terms and conditions set forth in the contract, copy of which shall form as integral part of this Resolution;
