A RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF PINAMALAYAN REPRESENTED BY THE MUNICIPAL MAYOR, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH CENTER FOR HEALTH DEVELOPMENT (MIMAROPA) THROUGH ITS REGIONAL DIRECTOR, MARIO S. BAQUILLO, MD, CESO IV FOR THE IMPLEMENTATION OF THE PROJECT "COMPLETION/UPGRADING/REPAIR OF PINAMALAYAN RURAL HEALTH UNIT (RHU).

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom for its efficient and effective governance, and those which essential to the promotion of the general welfare pursuant to the Local Government Code of 1991;

WHEREAS, Center for Health Development MIMAROPA is a Department of Health Regional Office responsible for ensuring access to basic public health services to all Filipinos through the provision of quality health care and regulation of health goods and services;

WHEREAS, the Center for Health Development MIMAROPA granted the Health Facilities Enhancement Program (HFEP) project entitled "Completion /Upgrading/Repair of Pinamalayan RHU" under the 2023 General Appropriations Act (GAA) with total allocation of Php 5,000,000.00;

WHEREAS, the welfare of the constituents is one of the utmost concern of this local government unit, further it is desirous to enhance the services being delivered to the public;

WHEREAS, the Municipal Government of Pinamalayan and Center for Health Development MIMAROPA are amenable with the terms and conditions set forth in the MOA, copy of which shall form as integral part of this Resolution;

Baquilod, MD, CESO IV for the implementation of the project "Completion/Upgrading/Repair of Pinamalayan Rural Health Unit (RHU).
