A RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF PINAMALAYAN REPRESENTED BY THE MUNICIPAL MAYOR, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH CENTER FOR HEALTH DEVELOPMENT (MIMAROPA) THROUGH ITS REGIONAL DIRECTOR, MARIO S. BAQUILOD, MD, CESO IV FOR GRANTING HEALTH EMERGENCY ALLOWANCE (HEA) TO ELIGIBLE PUBLIC AND PRIVATE HEALTH CARE AND NON-HEALTH CARE WORKERS OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, the allocation of funds for the HEA shall be based on risk exposure categorization of the health care workers and non-health care workers in particular setting: Three Thousand (Php 3,000.00) Pesos for low risk, Six Thousand (Php 6,000.00) Pesos for medium risk and Nine Thousand (Php 9,000.00) Pesos for high risk as stipulated in Sec. 5 of the same Act;

WHEREAS, Center for Health Development MIMAROPA is a Department of Health Regional Office responsible for ensuring access to basic public health services to all Filipinos through the provision of quality health care and regulation of health goods and services;

WHEREAS, the Municipality of Pinamalayan provides medical, dental and nursing services to the constituents of this municipality and provides information services on health and sanitation;
