RESOLUTION NO. 195-2023

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO A LEASE CONTRACT WITH PANALIGAN BUILDING RENTAL FOR THE RENTAL OF A TEMPORARY OFFICE SPACE FOR CRIMINAL INVESTIGATION AND DETENTION GROUP (CIDG).

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom for its efficient and effective governance, and those which essential to the promotion of the general welfare pursuant to the Local Government Code of 1991;

WHEREAS, Section 444 (1) (vi) of the same Code states that the Local Chief Executive shall represent the municipality in all its transactions and sign on its behalf all bonds, contracts and obligations, and as such other documents made pursuant to law or ordinance upon authorization by the Sangguniang Bayan;

WHEREAS, Panaligan Building Rental, a duly organized commercial enterprise offers office space for a monthly rental of Twelve Thousand Five Hundred (Php12,500.00) pesos for six months from July 2023 to December 2023;

WHEREAS, recognizing the importance of providing a temporary office for the Criminal Investigation and Detention Group (CIDG), the Municipal Government of Pinamalayan voluntarily accepts the offer extended by Panaligan Building Corporation.

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Local Chief Executive, Hon. Aristeo Apasan Baldos, Jr. to enter into a lease contract with Panaligan Building Rental for the rental of a temporary office for the Criminal Investigation and Detention Group (CIDG).
