Aristeo Apasan Baldos, Jr. to enter into a Memorandum of Agreement (MOA) with the City Government of Sto. Tomas, Batangas for the establishment of a sisterhood relationship.

WHEREAS, the Sangguniang Bayan supports the noble intention of forging inter-local government friendship and partnership in the pursuit of mutually beneficial objectives along socio-cultural and economic aspects of development;

WHEREAS, the City Government of Sto. Tomas, Batangas approved the establishment of a sisterhood relationship through Sangguniang Panlungsod Resolution No. 2023-457;

WHEREAS, the Municipality of Pinamalayan, Province of Oriental Mindoro expresses a proposal for the establishment of sisterhood relationship with the City of Iloilo by virtue of Sangguniang Bayan Resolution No. 294-2022;

WHEREAS, SECTION 444 (1) (VI) of RA 7160 states that the Local Chief Executive shall represent the municipality in all its transactions and sign on its behalf all bonds, contracts and obligations, and as such other documents made pursuant to law or ordinance upon authorization by the Sangguniang Bayan;

WHEREAS, the Department of Interior and Local Government (DILG) has outlined the guidelines on the establishment of National and International Sister-City or Town Twinning Program as enunciated in DILG Memorandum Circular No. 97-306 and 2012-23;


