A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASABALDOS, JR. TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE FOR THE IMPLEMENTATION OF PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) SCALE-UP IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, in accordance with Section 444 of the Local Government Code of 1991, the Local Chief Executive is empowered to represent the municipality in various business transactions and is duly authorized by the Sangguniang Bayan to execute bonds, contracts, obligations, and other legally mandated documents.

WHEREAS, the Department of Agriculture (DA) has been actively executing the Philippine Rural Development Project (PRDP) since its inception in 2014, and is presently introducing innovative methodologies to involve rural communities, Local Government Units (LGUs), and national government agencies in the planning, design, and execution of rural development initiatives;

WHEREAS, the PRDP Scale-Up is a continuation or expansion of the original PRDP, which is a project funded by the Philippine government, the World Bank, and other partners;

WHEREAS, the program aims to establish the general engagement by and between the parties under PRDP Scale Up and/or institutionalize overall partnership between the DA and the local government unit in the integrated delivery of devolved agriculture and fishery services and in improving LGU resource management, encompassing governance systems and mechanism;

WHEREAS, the Municipality of Pinamalayan has manifested its interest in partaking in the Project's implementation and has submitted all the necessary documentary prerequisites to the Department of Agriculture in relation to its proposed Sub-projects.



WHEREAS, the Municipal Government of Pinamalayan and the Department of Agriculture are amenable with the terms and conditions set forth in the Memorandum of Agreement, copy of which shall form as integral part of this Resolution.

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Local Chief Executive, Hon. Aristeo Apasan Baldos, Jr. to enter into Memorandum of Agreement (MOA) with the Department of Agriculture for the implementation of Philippine Rural Development Project (PRDP) Scale-Up in the Municipality of Pinamalayan, Oriental Mindoro.
