RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF PINAMALAYAN TO ACCEPT DONATION COMPRISING TWO (2) UNITS OF COMPUTER WITH PRINTER AND UNINTERRUPTED POWER SUPPLY FROM THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO.

WHEREAS, the Local Chief Executive is empowered to represent the municipality in all of its business transactions and is authorized to sign on its behalf all bonds, contracts, and obligations, and other documents as mandated by law or ordinance, subject to authorization by the sangguniang bayan, as stipulated in Sec. 444, (1)(b)(vi) of the Local Government Code of 1991;

WHEREAS, Local Chief Executives may, upon authority of the sanggunian, negotiate and secure financial grants and donations in kind, in support of the basic services or facilities from local and foreign assistance agencies pursuant to Section 23 of the same code;

WHEREAS, the Provincial Government of Oriental Mindoro (PGOM) freely and voluntarily give, transfer and convey by way of donation to the Municipality of Pinamalayan two (2) sets of computers complete with printer and Uninterrupted Power Supply (UPS) to be used solely by the Municipal Assessor's Office in encoding the Real Property Assessment Data, for the General Revision of Assessment (GRA);

WHEREAS, this municipality gratefully accepts the aforementioned donation, comprising two sets of computers with printer and UPS, and sincerely acknowledges the profound benevolence demonstrated by the PGOM.
