RESOLUTION CONFIRMING MUNICIPAL SCHOLARSHIP COMMITTEE RESOLUTION NO. 02, S. 2023 ENTITLED: "A RESOLUTION RECOMMENDING THE TERMINATION OF THE SCHOLARSHIP OF MS. CHERALDYN T. VITTO, SCHOLARSHIP GRANTEE UNDER THE ENHANCED PINAMALAYAN SCHOLARSHIP PROGRAM OF THE MUNICIPAL GOVERNMENT OF PINAMALAYAN."

WHEREAS, the Municipal Scholarship Committee is duly constituted through Executive Order No. 51-2026 signed by the Municipal Mayor Aristeo A. Baldos, Jr., under Municipal Resolution No. 039-(A)-2008 and Ordinance No. 03-2018;

WHEREAS, Municipal Scholarship Committee Resolution No. 02-2023 recommends the termination of Ms. Cheraldyn T. Vitto's scholarship under the Enhanced Pinamalayan Scholarship Program of the Municipal Government of Pinamalayan due to the alleged forged documents she submitted from EMA-EMITS College Philippines and non-compliance of securing clearance before enrollment;

WHEREAS, the two aforementioned acts are serious violations of the program's policies and guidelines according to ESP Policy, Section X, Page 4, Terms and Conditions of the Scholarship Program;

WHEREAS, it is stipulated in the ESP Policy, Section XII, Item No. 7, Page 5, General Provisions of the program that the decision of the Municipal Scholarship Committee shall be final upon approval of the Sangguniang Bayan; hence this resolution.

NOW THEREFORE, BE IT RESOLVED by the 11th Sangguniang Bayan of Pinamalayan, Oriental Mindoro to confirm Municipal Scholarship Committee Resolution No. 02, S. 2023 entitled: "A Resolution Recommending the Termination of the Scholarship of Ms. Cheraldyn T. Vitto, Scholarship Grantee under the Enhanced Pinamalayan Scholarship Program of the Municipal Government of Pinamalayan";
