**WHEREAS**, based on the assessment conducted by the Municipal Engineering Office, subject building/structure installed and constructed in the playground is no longer safe for use of the children and it is prone to accident, hence, it is recommended to be removed;

**WHEREAS**, the Sangguniang Bayan hereby confirmed the Demolition Permit Application applied by the Municipal Engineer due to present condition of the Children Playground Building/Structure in the area consistent with the government's aims to provide a more proactive and preventive approach to secure safety of the constituents especially children;

**NOW THEREFORE, BE IT RESOLVED** by the 1<sup>st</sup> Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Municipal Engineering Office to conduct demolition and clearing activity of Children Palyground Building/Structure located at the Municipal Park, Pinamalayan, Oriental Mindoro.
