A RESOLUTION RESPECTFULLY REQUESTING FINANCIAL ASSISTANCE FROM HON. ALFONSO V. UMALI, CONGRESSMAN OF THE 2ND DISTRICT OF ORIENTAL MINDORO, FOR THE CONSTRUCTION OF LEGISLATIVE BUILDING WORTH OF TWENTY MILLION PESOS (PHP 20,000,000.00) IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, presently, the shared office of the Sangguniang Bayan Members cannot accommodate number of clients due to its limited space and the Session Hall is also utilized as venue for the conduct of Committee meetings/hearings and other meetings of other offices;

WHEREAS, the Sangguniang Bayan of Pinamalayan is in dire need of a separate legislative building to promote a conducive working environment for officials and employees and a convenient space for clientele;

WHEREAS, the establishment of the proposed Legislative Building will significantly strengthen the capacity of the public servants and will enable them to elevate their level of performance in the delivery of necessary services to the public;

WHEREAS, due to financial constraints of the Municipal Government of Pinamalayan, proposed construction of Legislative Building had not materialized, hence, this earnest request for financial assistance.

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Oriental Mindoro to request Hon. Alfonso "PA" Umali, Congressman, 2nd District for Financial Assistance for the Expansion of Municipal Building in the amount of **Twenty Million Pesos (Php 20,000,000.00).**
