RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF PINAMALAYAN REPRESENTED BY THE MUNICIPAL MAYOR, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) (KALATAS NG KASUNDUAN) WITH BARANGAY LOCAL GOVERNMENT UNIT OF PILI, SAMAHAN SA BARANGAY PILI SA PANGANGALAGA NG KALIKASAN (SBPPK), PROVINCIAL AGRICULTURE OFFICE-FISHERY AND COASTAL RESOURCE MANAGEMENT DIVISION, PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (PENRO) AND MALAMPAYA FOUNDATION, INC. FOR THE MANAGEMENT OF BARANGAY PILI WATER SYSTEM, PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, in accordance with the Local Government Code of 1991, every local government unit is mandated to exercise powers explicitly granted, those necessarily implied for the efficient and effective governance, and those essential to the promotion of the general welfare;

WHEREAS, it is the duty of local government units to actively participate in the management and enhancement of water quality within their respective territorial jurisdictions, in line with Republic Act No. 9275, also referred to as the "Philippine Clean Water Act of 2004";

WHEREAS, the Barangay Local Government Unit of Pili, in collaboration with the Samahan sa Barangay Pili sa Pangangalaga ng Kalikasan (SBPPK), the Provincial Agriculture Office-Fishery and Coastal Resource Management Division, the Provincial Environment and Natural Resources Office (PENRO), and Malampaya Foundation, Inc., manifests their commitment to actively participate in the monitoring, proper management, and effective implementation of Barangay Pili Water System by virtue of Memorandum of Agreement (Kalatas ng Kasunduan) to be executed by all parties concerned;

WHEREAS, the Municipal Government of Pinamalayan continuously endeavors to attain its primordial objective of providing safe and clean water for the well-being of its constituents;
