RESOLUTION NO. 309 - 2023

RESOLUTION DECLARING THE ENTIRE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO UNDER THE STATE OF CALAMITY DUE TO AFRICAN SWINE FEVER (ASF) OUTBREAK.

WHEREAS, Section 447 (a) of RA 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sect. 16 of this code;

WHEREAS, the Sangguniang Panlalawigan thru Resolution No. 6658-2023 dated November 7, 2023 has declared the five (5) municipalities including the Municipality of Pinamalayan in the Province of Oriental Mindoro under State of Calamity due to ASF outbreak;

WHEREAS, item 4.a.ii, of the National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum Order No. 60, s. 2019, provides that when two or more barangays are affected by a disaster, the Sangguniang Bayan or Panlungsod, upon the recommendation of the Municipality DRM Council, may declare the entire municipality or city under the state of Calamity;

WHEREAS, Municipal Disaster Risk Reduction and Management Council (MDRRMC) recommends the declaration of Municipality of Pinamalayan under the State of Calamity due to African Swine Fever (ASF) outbreak in barangays Sta. Isabel, Bull, Anoling, Palayan, Marfrancisco, Papandayan, Cacawan, Panggulayan as reflected in MDRRMC Resolution No. 08-2023;

WHEREAS, this incident is detrimental to socio-economic wellbeing of the residents, most especially the local hug raisers, farmers, meat vendors and food business owners whose livelihood was adversely affected;

WHEREAS, the Municipal Government of Pinamalayan in its relentless pursuit of protecting the constituents particularly in time of calamities has identified interventions to mitigate the socio-economic impact caused of ASF outbreak;

WHEREAS, the Sangguniang Bayan recognizes the necessity of this declaration to ensure the timely and efficient delivery of interventions to address the impact of ASF outbreak;

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Oriental Mindoro to declare the entire Municipality of Pinamalayan, Oriental Mindoro under the State of Calamity due to African Swine Fever (ASF) outbreak.

UNANIMOUSLY APPROVED this 21st day of November 2023 on mass motion of all Sangguniang Bayan Members present.
