RESOLUTION ADOPTING AND APPROVING MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRMC) RESOLUTION NO. 10-2023 ENTITLED: "RESOLUTION RECOMMENDING THE REALIGNMENT, REPROGRAMMING, AND UTILIZATION OF MDRM QUICK RESPONSE FUND CY 2023 AMOUNTING TO PHP 5,206,721.10, AND CURRENT 70% MDRM FUND AMOUNTING PHP 2,895,111.90 WITH A TOTAL OF PHP 8,101,833.00 FOR THE PROVISION OF FUND TO THE PROGRAMS, PROJECTS, AND ACTIVITIES TO ADDRESS THE AFRICAN SWINE FEVER (ASF) OUTBREAK IN THE MUNICIPALITY".

WHEREAS, provided in the Republic Act 10121 also known as the Philippine Disaster Risk Reduction and Management Act of 2010, under Section 21, Local Disaster Risk Reduction and Management Fund (LDRRMF), Unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRMCs within the next five (5) years;

WHEREAS, Section 21 of RA 10121 provides that upon the recommendation of the Local Disaster Risk Reduction and Management Office (LDRRMO) and approval of the local Sanggunian, the LDRRM Council may transfer the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk reduction work which are declared under the state of calamity;

WHEREAS, the Sangguniang Panlalawigan thru Resolution No. 6658-2023 dated November 7, 2023 has declared the five (5) municipalities including the Municipality of Pinamalan in the Province of Oriental Mindoro under State of Calamity due to ASF outbreak;

WHEREAS, the amount Php 5,206,721.10 from 30% Quick Respond Fund and Php 2,895,111.90 from 70% Disaster Prevention and Mitigation and Disaster Preparedness Fund for CY 2023 was certified by the Municipal Accountant as unutilized balance of MDRRMF which shall be available balance free from any obligation;



WHEREAS, the amount of Ph 2,895,111.90 from 70% Disaster Prevention and Mitigation and Disaster Preparedness Fund shall be appropriated for the following PPAs of MDRRMC; to wit:

WHEREAS, the aforementioned amount shall be appropriated for the ASF Prevention and Control Program of the Municipality identified in the approved Supplemental Investment Program (SIP) No. 04-2023;

WHEREAS, the Sangguniang Bayan firmly believes the importance of aforementioned program for the prevention and mitigation of the impact of ASF outbreak.

NOW THEREFORE, BE IT RESOLVED by the 1st Sangguniang Bayan of Pinamalayan, Oriental Mindoro to adopting and approving Municipal Disaster Risk Reduction And Management Council (MDRMC) Resolution No. 10-2023 entitled: "Resolution recommending the realignment, reprogramming, and utilization of MDRRM Quick Response Fund CY 2023 amounting to Php 5,206,721.10, and current 70% MDRRM Fund amounting to Php 2,895,111.90 with a total of Php 8,101,833.00 for the provision of fund to the programs, projects, and activities to address the African Swine Fever (ASF) outbreak in the municipality".

UNANIMOUSLY ADOPTED AND APPROVED this 21st day of November 2023 on motion of Hon. Edwin G. Hernandez and seconded by all Sangguniang Bayan Members present.
