RESOLUTION NO. 389- 2023

RESOLUTION ADOPTING AND APPROVING THE MUNICIPAL CONTINGENCY PLAN FOR TYPHOON, FLOOD AND EMERGING AND RE-EMERGING INFECTIOUS DISEASE (EREID) 2024-2026 OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, Section 16 of RA 7160, otherwise known as Local Government Code of 1991, provides that “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, xxx convenience of their inhabitants;

WHEREAS, Republic Act No. 10121, otherwise known as the *Philippine Disaster Risk Reduction and Management Act of 2010*, empowers LGUs to provide mitigating and preventive programs, prepare for and earnestly respond to disaster, calamities, crisis, complex emergencies, and attend to relief and rehabilitation work through a contingency plan;

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) has formulated a contingency plan consistent with the prevention, mitigation, preparedness, response, relief and rehabilitation in times of typhoon, flood and emerging and re-emerging infectious disease;

WHEREAS, subject MDRRMC Resolution No. 11- 2023 was indorsed to the Sangguniang Bayan for review and appropriate action as provided in Section 114 of the Local Government Code of 1991;

WHEREAS, the Contingency Plan for Typhoon, Flood and EREID is an effective tool as an emergency response during calamities and emergencies situation as well as a guide in the provision of effective health services to the public.

NOW THEREFORE, BE IT RESOLVED by the 11th Sangguniang Bayan of Pinamalayan, Oriental Mindoro to adopt and approve the Municipal Contingency Plan For Typhoon, Flood and Emerging and Re-Emerging Infectious Disease (EREID) 2024-2026 of Pinamalayan, Oriental Mindoro.
